

# **KPH Privacy Policy**

#### Introduction

By taking part in our actions, you join the movement of people who are not indifferent to the rights of the LGBT+ community, and you agree that the Campaign Against Homophobia Association (hereinafter referred to as the Association or KPH), based in Warsaw, address Aleje Jerozolimskie 99/40, 02-001 Warsaw, KRS 00001111209, will become the administrator of your personal data.

Your provision of data is voluntary, but necessary. If you do not agree to provide it, we will not be able to record your activities on our website. We process them on the basis of applicable laws (including EU Regulation 2016/679 of April 27, 2016).

#### Why do we collect, store and process your data?

We collect and process your personal data to enable you to receive information about the LGBT+ community and KPH's activities and to give you the opportunity to get involved.

We process your personal data in order to be able to carry out activities in the public interest and the legitimate interest of KPH in fulfilling our statutory objectives (see our statutes on the KPH website https://kph.org.pl/o-kph/misja-i-wizja-dokumenty/kph statut 2018) and the need to pursue or defend against claims.

We will process your personal data in order to perform the above-mentioned tasks, provided that you expressly consent to the processing. We assure you that your personal data will be processed only to the extent necessary to fulfill the purposes for which they were provided.

## What kind of data do we collect?

We collect only the necessary data. You can update this information at any time. You can provide the data:

- in person or by phone,
- when registering via the KPH contact form,
- when registering on our action pages.

If you agree, we may ask you to share the following information:

- name (and surname),
- contact information (e.g., e-mail address, place of residence, postal code, telephone number, country in the case of people residing outside Poland),
- preferences regarding communication with us what information you want to receive from us, interests in subject areas you want to learn more about.

The purpose of processing the above data is to operate the Engaging Networks platform for managing personal data by KPH. To be able to send information according to your preferences and interests. Once the above data is collected and processed, it will be subjected to profiling. KPH monitors the open and click-through rates of emails sent. We use this information for statistical and reporting purposes.

#### Who are the recipients of your personal data?

The recipients and recipients to whom your personal data may be transferred will be IT service providers. KPH does not share data collected for through campaigns conducted on its pages, unless the actions taken by you in the campaign require it.



When we collect signatures on a petition, we will provide the person to whom it is addressed with a list of the names and zip codes of the people who have signed.

If you participate in a campaign that involves sending e-mails to a selected person, such as a specific parliamentarian or parliamentarian, then that person will receive a message with your name and e-mail address.

KPH may also provide your personal data to entities performing public tasks (to the extent of their performance of such tasks) in situations where such obligation arises by law.

Your personal data may be transferred outside the European Economic Area, to countries that do not provide an adequate level of data protection, but in this case adequate safeguards will be provided for the protection of your personal data in the form of standard data protection clauses adopted by the European Commission.

### How long are the data stored?

We will keep your personal data for as long as the relevant legal provisions allow, in particular the statute of limitations for claims. In determining the period of data processing, KPH will also take into account the expectations of the relevant data protection authority.

#### What rights of management of your data do you have?

Under the RODO, you have the right to:

- withdraw your consent to the processing of your personal data at any time without prejudice to the processing of your data prior to the withdrawal of your consent,
- to access your data and receive a copy of it,
- rectify (amend) your data,
- restrict or object to the processing of your data,
- to receive and transfer the personal data provided by you to another data controller,
- the right to lodge a complaint to the President of the Office for Personal Data Protection (to the address of the Office for Personal Data Protection, 2 Stawki Street, 00-193 Warsaw).

#### Who to contact regarding the management of your data?

We are committed to making you feel secure, so you can always contact KPH to exercise your rights, including withdrawal of the consent you have given for the processing of your personal data and any other issues related to the processing of your data.
